Secondary source data, mainly from the U.S. Department of Agriculture, but also other sources, are considered a census of available price information. No sampling variability exists in those percent change estimates, so the standard error values are zero. The FD-ID index for Unprocessed Foodstuffs and Feedstuffs is constructed almost exclusively from non-sampled price data, and at certain levels of aggregation, other FD-ID indexes include both sampled and non-sampled data.
